#### II. Approval of the Agenda as presented.

#### **III.** Public Comments:

- A. Peggy Williford
  - 1. The final billing of \$4,435.00 has been submitted from Bornholdt Plantland. The balance in donations made by citizens is \$2,835.15 plus \$711.99 from sale of ads in directory, leaving a balance of \$887.86 to be raised by the committee.
  - 2. City council thanked everyone on Peggy's committee who did the volunteer work and raised the funds.

A. Mayor

- 1. Tree Lights were installed at entrance
  - Greig Sims grandson Gabriel provided a bucket truck to install lights on the tree.
  - Volunteers Peggy Williford, Randy Miller, Butch Neel and Carol Moore assisted in hanging lights.
- B. Treasurer
  - 1. General fund beginning balance \$75,421.68, income \$4,990.72 less \$29,170.46 and transfer \$141.70 to American Rescue fund, October 31, 2021, balance in General Fund \$51,10.24.
  - 2. Business Share Account Heartland Credit Union \$25.00
  - 3. Capital Improvement Fund \$80,764.83
  - 4. Equipment Fund \$25,604.73
  - 5. Parks and Recreation Fund \$4,332.24
  - 6. American Rescue Fund \$23,959.64, this fund is set aside until the city council gets instructions how it can be spent.
  - 7. Total Unencumbered Cash \$185,786.68
  - 8. Tax statement and Mill Levy are posted on the website.

#### C. AZC report

- 1. Status of road repairs: APAC has closed its plant for the season.
  - Powered by Me will start tarring. Tar is \$1,525 per pallet.
  - Powered by Me billing for work to date is \$22,280.00.

#### Jennalee Boggs made a motion to pay Power by Me \$22,280.00, seconded by Butch Neel. Motion passed.

- 2. Permits:
  - Matt Ahlstedt with Crazy Communication paid \$50 fee for their special use permit to begin laying fiber optic lines in right of ways of The Highlands. Work will begin with Phase I in February 2022 and complete December 31, 2022; Phase II January 1, 2023, and complete August 31, 2023, Phase III begin September 1, 2023, and complete in December 31, 2023.
